# Agricultural Vehicles... Did You Know?



**Certain classes of commercial vehicle, such as mowing machines and off-road tractors, are exempt from vehicle tax. However, they still need to display a 'nil' tax disc that has to be renewed each year. If you don't have this free tax disc on your vehicle you may be fined, even though no tax is due.**

All vehicles operated privately or commercially are liable for vehicle tax however the following are exempt.

## **Agricultural, horticultural and forestry vehicles**

These vehicles must be used solely for the purpose of agriculture, horticulture and forestry and can be taxed either in the 'agricultural machine' or 'limited use' tax class.

## **Agricultural machines**

The following vehicles are taxed in the 'agricultural machine' tax class:

- **agricultural tractors**, which are used on public roads for agriculture, horticulture or forestry purposes, or for cutting verges, hedges or trees bordering public roads
- **off-road tractors**, which are non-agricultural tractors used more off- than on-road and which are not capable of travelling at more than 25 miles per hour under their own power
- **agricultural engines**, which are specially designed or permanently converted to perform agricultural operations on the land - eg a combine harvester

- **light agricultural vehicles**, which weigh less than 1,000 kilograms, are designed with only a driver's seat, are used primarily off-road and are used for agriculture, horticulture or forestry
- **agricultural lift and loading vehicles** that are designed for off-road use and for lifting and loading only within agriculture, horticulture or forestry activities

## **Limited use vehicles**

You can tax your vehicle in the 'limited use' tax class if it is used solely for agriculture, horticulture or forestry purposes and on public roads only for passing between different areas of land occupied by the same person, and travelling no more than 1.5 kilometres in doing so.

# *YES Claim Bonus - extended to taxi and chauffeur fleets*

**'Yes Claim Bonus' looks to reward early notification of accidents to the insurer. From May 2009, all new and existing clients with a TFP Single Taxi policy involved in an accident benefited from a £200 reduction in their excess if they:**

- provide contact details for any third parties involved.

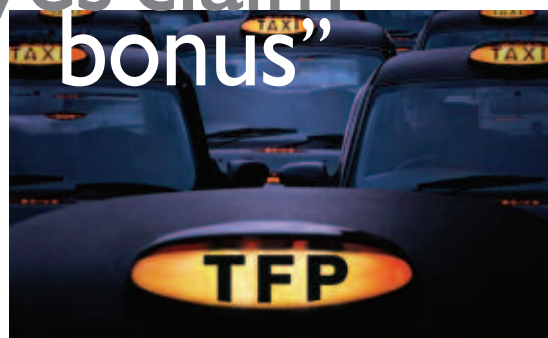
The reduction in the excess has led to a significant shift in claims reporting behaviour with the number of fault claims reported within the first 24 hours of an incident increasing by almost 70%. All of which can mean huge savings in controlling third-party claims costs, as well as assisting in the early detection of fraudulent claims.

### Legislation covering Funeral Directors

There is no legislation specifically for funeral directors. However, as a business person engaging in activities that are potentially hazardous to both people and the environment, there is certain legislation that Funeral Directors should be aware of.

### Health and safety and environmental legislation

- the Public Health Act empowers local authorities to pass bye-laws governing the use and provision of mortuaries and post-mortem rooms. A check with the local authority environmental health department for details of any relevant bye-laws in the area should be undertaken
- the Public Health (Control of Diseases) Act and regulations made under it cover situations where a

person dies while suffering from a notifiable disease, and restricts the period of time for which a body may be retained after death

- the Control of Substances Hazardous to Health (COSHH) Regulations cover the storage and use of chemicals
- the Environmental Protection Act regulates the disposal of waste chemicals, detergents and so on
- the Health and Safety at Work Act and the numerous regulations made under it cover all aspects of health and safety. Funeral Directors have a duty to ensure the health and safety at work of all their employees and those with more than five employees must prepare a written health and safety policy statement. Some key areas where health and safety regulations affect a business, includes the use of electrical equipment, adequate provision of protective clothing and equipment and the reporting of any accidents at work.
